The motion was seconded by Supervisor Deanes.

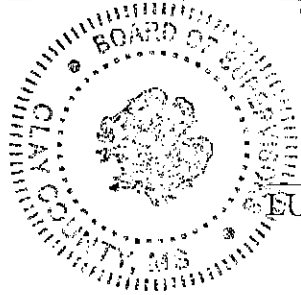
