#### Departmental Report – May 6, 2021

#### **MSU Extension**

Extension work has been picking up. Farmers have been busying trying to get crops planted between the thunderstorms and rain. Cattle prices were up and grain prices were on the rise, but not much other farming activity to report. The Cattlemen's Association hosted their first quarterly meeting on April 8 with approximately 27 members in attendance. The Jimmy Bryan 4-H Youth Complex played host to the Northeast District 4-H SAFETY Event on April 24. It brought approximately 200 4-Her's plus parents, agents, and volunteers from across a 22 county area. Six 4-Hers from Clay County competed in the event. Two junior 4-Hers won both their divisions in .22 Rifle and two 4-Hers qualified to compete at the State 4-H S.A.F.E.T.Y. Event in July. The July event will also be held at the Jimmy Bryan 4-H youth Complex. I would like to thank Sherriff Scott and his staff for providing some inmate labor to weed-eat around the facility before the event. Extension Administration and the State 4-H office is looking into hiring a part-time person to handle maintenance and up keep of that facility. I do not know all the details or a description of what that position would entail, but I would like them to meet with the Board of Supervisors before making that decision to explore some options. We have also narrowed down the candidates for the Office Associate position and will interview the top three candidates on Monday, May 10.

#### **Clay County Fire**

Call volume was increased during the month of April, particularly structure fires and vehicle accidents. Possible causes due to heaters being used again during a period of cooler weather during the month; one fire is under investigation. Then there was the usual handful of EMS, Fire Alarm, Gas calls, and Controlled Burns.

# EXHIBIT M

Following the reading of the bids, the Board of Supervisors (the "<u>Governing Body</u>") of Clay County, Mississippi (the "<u>County</u>"), acting for and on behalf of Supervisor District Two of the County (the "<u>District</u>"), proceeded to consider them for the purpose of determining which was the best and most advantageous bid submitted. Whereupon, the following resolution was presented, read and its adoption and passage moved by Supervisor <u>Hortow</u>:

#### RESOLUTION DIRECTING THE SALE AND AWARD OF GENERAL OBLIGATION ROAD AND BRIDGE BONDS, SERIES 2021, OF SUPERVISOR DISTRICT TWO OF CLAY COUNTY, MISSISSIPPI, IN THE PRINCIPAL AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000).

WHEREAS, the Governing Body of the County, acting for and on behalf of the District, nereby finds, determines, adjudicates and declares as follows:

1. The Governing Body, on April 22, 2021, did adopt a resolution (the "<u>Bond</u> <u>Resolution</u>") directing that General Obligation Road and Bridge Bonds, Series 2021 (the <u>'Bonds</u>"), of the District in the principal amount of Five Hundred Thousand Dollars (\$500,000) be offered for sale on sealed bids to be received up to and until the hour of 11:00 o'clock a.m. on May 6, 2021.

2. As directed by the Bond Resolution, notice of sale of the Bonds (the "<u>Notice of</u> <u>Sale</u>") was duly published in the *Daily Times Leader*, a newspaper published in and having general circulation in the County, and qualified under the provisions of Section 13-3-31, Mississippi Code of 1972, as amended, the Notice of Sale having been published on April 24 and May 1, 2021, in said newspaper, the first publication having been made at least ten (10) days preceding May 6, 2021, all as shown by the proof of publication of the Notice of Sale filed in the office of the Clerk of the Governing Body (the "<u>Clerk</u>").

3. The Governing Body did meet at its meeting place in the Clay County Courthouse in the City of West Point, Mississippi, at 11:00 o'clock a.m. on May 6, 2021.

4. At said time and place three (3) sealed proposals for the purchase of the Bonds (the "<u>Proposals</u>") were received, examined and considered by the Governing Body, said bids having heretofore been presented by and being on file with the Clerk. After such examination of the Proposals by the Governing Body, it was determined that only two (2) of the Proposals were qualified pursuant to the terms and conditions set forth in the Notice of Sale.

5. The Governing Body does now find, determine and adjudicate that the highest and best qualified bid made and offered for the Bonds on the basis of the lowest net interest cost over the life of the issue was made by Bank of Commerce, located in West Point, Mississippi, and said bid was accompanied by a cashier's check, certified check or exchange payable to Supervisor District Two of Clay County, Mississippi, in the amount of Ten Thousand Dollars (\$10,000), issued or certified by a bank located in the State of Mississippi, as a guarantee that said bidder would carry out its contract and purchase the Bonds if its bid be accepted.

## NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY, ACTING FOR AND ON BEHALF OF THE DISTRICT, AS FOLLOWS:

**SECTION 1.** The Bonds are hereby awarded and sold to the Bank of Commerce, located in West Point, Mississippi, in accordance with the offer submitted to the Governing Body, acting for and on behalf of the District, in words and figures as follows:

**SECTION 2.** The President of the Governing Body and the Clerk are hereby authorized and directed to endorse upon a copy or duplicate of the aforesaid offer a suitable notation as evidence of the acceptance thereof, for and on behalf of the District.

**SECTION 3.** The good faith checks filed by all unsuccessful bidders shall forthwith be returned to them upon their respective receipts therefor, and the good faith check filed by the successful bidder shall be retained by the Governing Body, acing for and on behalf of the District, as a guarantee that said bidder shall carry out its contract and purchase the Bonds. If said successful bidder fails to purchase the Bonds pursuant to its bid and contract, the amount of such good faith check shall be retained by the County, acting for and on behalf of the District, as liquidated damages for such failure.

**SECTION 4.** The Bonds shall be in fully registered form; shall be dated the date of delivery; shall be of the denomination of \$5,000 each or integral multiples thereof up to the amount of a single maturity; shall be numbered from one (1) upward in order of issuance; shall be payable, both as to principal and interest, in lawful money of the United States of America at the office of the Chancery Clerk of the County, said Chancery Clerk to act as paying agent, registrar and transfer agent for said Bonds; shall bear interest from the date thereof at the rates hereinafter set forth, payable semiannually on June 1 and December 1 in each year (each an "Interest Payment Date"), commencing June 1, 2022; and shall mature and become due and payable serially, on June 1 in the years and principal amounts as follows:

Bonds maturing on June 1, 2029 and thereafter, are subject to redemption prior to their stated dates of maturity, at par, plus accrued interest to the date of redemption, either in whole or part, at any time on or after June 1, 2028.

**SECTION 5.** All orders, resolutions or proceedings of this Governing Body in conflict with the provisions of this resolution shall be and are hereby repealed, rescinded and set aside, but only to the extent of such conflict.

**SECTION 6.** For cause, this resolution shall become effective immediately upon the adoption thereof.

If he sees any illegal dumping activity, he takes pictures, and documents the activity, and goes through the trash to identify the names and addresses. If he is able to find names and addresses in the trash, he and a Sheriff's Deputy make contact with people, request they pick up the trash, and warn them of any future findings there will be legal consequences. If he is unable to locate any names in the trash, he and his crew remove and properly dispose of the trash. Any type of funding assistance for Mr. Heard's salary would be beneficial to the county. Currently, Mr. Heard's salary is \$39,310.92
