There are several different components to the operations of 911.

Radio System- \$197,771.00

Have a quote for new system, \$197K to ComSouth. We have obtained two quotes. Both systems are listed on the State's EPL Pricing List. Upon approval by the Wireless Communication Commission (WCC), the purchase of the equipment from lowest vendor is exempt from reverse auction process and advertising for bids. Will take a week to for shipping and a week to install.

\$223,594.00

This system is brand new. It was bought in December AT & T provides the service. It cost the County \$230K. We have an active L/P against the equipment. The equipment is Motorola equipment. HP Tech Group repair Motorola Equipment. An initial assessment has been completed. Parts were ordered. Should have been received Friday. HP Tech will arrive Monday. HP has indicated if this does not fix it, then they will recommend to AT & T it is a total loss. My question is, I need to check the warranty on the machine. Since we have only owned it for 8 months, I would think it should still be covered. There are 3 computers which the Phone system works off of. All of those computers are shot and new ones will need to be purchased.

Recording System

The Recording System is a component of the Phone System. Currently, since the 911 office is working remotely at a diff location. The Recording System is not working. However, once the Phone System is fixed and working at the primary location, the current recording system should be fine.

Currently, under contract with I/T Technician to fix this. We will need 3 new computers. The old ones were shot with the lightning. Once the computers are ordered and in, the fix will be networking. (\$100 per hour/ approximately 12 hours of work, plus the cost of 3 computers)

Tornado Sirens

Waiting on obtaining a quote for someone to come and look at. Hopefully should have more on this.

Camera System

There is a camera system around the 911 building. It is shot. Waiting on quote for this.

Mobile Radios

The 911 office had about 9-10 mobile MSWIN Radios. These were shot. Will be need be replaced. Waiting on a quote for replacement

Building Door Locks -

The Door locks to the building are not functioning right. Waiting for technician to come and look at and give a quote.

East Tower Generator-

A switch was blown on the generator. Waiting on Repair Tech to come and look at to give estimate.
