If he sees any illegal dumping, he takes pictures, documents the activity, and goes through the trash to find names and addresses in an effort to identify the individual who dumped the trash. If he is able to find names and addresses in the trash, he and a Sheriff's deputy go and make contact with the person, requesting them to pick up the trash by a certain deadline, and warns them of legal consequences if any future findings are found. If he is unable to locate any names in the trash, he and his crew remove and properly dispose of the trash. Mr Doss has been with the County for one (1) year now and does a great job! Any type of funding assistance for Mr Doss's salary would be beneficial to the County. Currently, Mr Doss's salary is \$31,088.




