### Reasons Why a Circuit Court Reporter Deserves a Pay Raise

- 16<sup>th</sup> Circuit Court District has an extremely high percentage of hearing, trial, and appeals as compared to other districts in the state
- Have frequent setting outside of the regularly scheduled court terms causing the court reporters to complete transcripts during the evening hours and or weekends
  Court Reporters have to also take settings outside of terms with Senior Judges who are handling recusal cases in our district
- Court Reporters have not had a full raise since 2003, not even the cost-of-living raises given to the other support staff employees in our district
- Officials cannot make extra money outside of their official duties because a MS Supreme Court order prohibits official reporters from taking depositions
- There is an overall shortage of court reporters in the state since Ole miss closed its program in 2002 Judge Kitchens has not been able to find a freelancer for all of his court dates while his reporter is on maternity leave
- Because the court reporter salary is lower in this district, it's difficult finding freelancers to fill in due to a lower pay rate per day since it is based on ou + salary It is also difficult attracting a new court reporter when one leaves due to the lower salary
- Judge Coleman had a reporter turn down the position that became available in July because she could make more money freelancing since the 16<sup>th</sup> Circuit District did not approve all three tiers of the raise
- Hiring a fourth reporter to help with the case load of the 16<sup>th</sup> Circuit District would cost the counties more than pay raises

# Circuit Court Reporter's Role and Responsibilities

- To be present at all court proceedings and make a verbatim official record with a stenographic machine
- To mark all exhibits and file them with the circuit clerk
- Transcribe and file appeals with the MS Supreme Court within 60 days while attending court terms, motion days and any special settings
- Transcribe all guilty pleas and file them in the court files
- Required to be certified with the state in order for transcripts to be accepted in any court. Certification requires the skill of writing a minimum of 225 words a minute on a stenographic machine.
