ROBERTS, TO ATTEND ADVANCED OPERATING SCHOOL TRAINING**


There came on this day for consideration the matter of authorizing travel for the K9 Unit Officer, Jordan Roberts, to attend advanced operating school training.

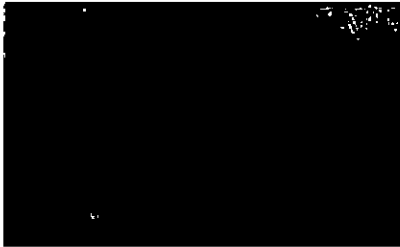




