The Emergency Road and Bridge Repair Fund was established by the Legislature to provide funding for emergency repairs, to include replacement, of public roads and bridges. The deficient conditions of many public roadways and bridges have negatively affected public safety, commerce, and the economic viability of the state.

In order to gain a better understanding of the types of emergency needs that exist at all levels of government, we are requesting information about the factors you consider in prioritizing your local emergency repair and replacement needs. Since this is a statewide look, public safety concerns as well as economic benefits at the state, regional, and local levels should be included.

List of factors considered in prioritizing local emergency repair and replacement needs:

- 1. Rehabilitate damaged roads and bridges prior to complete deterioration for more economical benefits.
- 2. Prioritize projects for long term benefits that affect the greatest number of citizens.
- 3. Reduce accidents, injuries, and damages to facilities and property.
- 4. Foster a safe and timely connected, accessible highway system that serves commerce, people, and emergency responders.

- 8. Partner with new and existing industries to provide the needed infrastructure for their success and the creation and preservation of jobs.

West Church Hill Road provides access from Highway 45 Alternate to numerous industrial, commercial and retail businesses employing approximately 800 people. See Exhibit I for Location Map. It is also heavily used by trucks for Prestage Farms and Steel City Recycling. Recently Peco Foods has announced that it is expanding operations and locating the expansion on West Church Hill Road. Construction traffic has already started and when completed, 300 employees and numerous more trucks will be traveling this road. The pavement is distressed throughout the entire 8,300 feet length. The eastern section has numerous transverse cracks and a few base failures. The western section has numerous fatigue cracks and base failures and has deteriorated to nearly complete loss of pavement. The existing pavement has a rough surface throughout causing noise pollution and damage to vehicles. Traffic count listed on MDOT web site is shown at 1,000 vehicles per day. With the recent commercial developments and Peco's location on the road, the traffic count is expected to increase. No detour route is available as West Churchill Road is a dead road. The estimated cost of the project \$1,000,000. The number of people and jobs associated with this project give it a regional impact. This access road is of the utmost importance to Clay County and the City of West Point as both are partnering to provide needed maintenance. The lack of available funds to do the project has created an emergency situation.


